

BUCKET HEAD COACH COMPETITION 2021 - TERMS & CONDITIONS

Promoter	Nationwide News Pty Limited (ABN 98 008 438 828), 2 Holt Street, Surry Hills NSW 2010.
Entry Restrictions	<p>Open only to Australian residents who are aged 13 or over. If an entrant is aged between 13 and 17 years of age (inclusive) at the time of entry, they must seek their parent or guardian's permission prior to entering the competition (including consenting on the entrant's behalf to these terms and conditions). Any Prize that may be won by an entrant aged between 13 and 17 years of age (inclusive) will be awarded to their parent / guardian. Minimal age to win any of the prizes sponsored by KFC is 14.</p> <p>Directors, officers, management and employees (and the immediate families of directors, officers, management and employees) of the Promoter or of the other agencies or companies associated with the conduct or running of this competition are ineligible to enter.</p>

Entry Method	<p>During the Competition Period, entrants must:</p> <ul style="list-style-type: none"> (a) be following the @buckethead_coach Instagram page; (b) open up the Bucket Head filter on Instagram; (c) choose their preferred position (batter or bowler) located in the filters drop down menu; (d) record their "best piece of banter"; (e) tag the @buckethead_coach Instagram page and use the #bucketheadcoach hashtag on the recording and post it onto their Instagram story or page; and (f) ensure their Instagram privacy settings are set to 'public' in order for the Promoter to retrieve the entry. <p>Selected recordings will then be uploaded by the Promoter to www.bucketheadcoach.com.au (the "Website").</p> <p>Recordings must not appear to promote or make reference to any supplier of goods or services other than the Promoter, its related third parties, or any sponsors of the competition.</p> <p>The Promoter reserves the right to remove, take down and report any entry that is not in accordance with the Promoter's brand guidelines or are otherwise deemed to be unsuitable.</p>

Entry Limits	<p>Entrants can enter as many times as they like during the Competition Period, provided that each entry recording is unique and based on a different piece of 'banter'.</p> <p>Entrants must not submit the same recording more than once during the Competition Period.</p>
Winner Notification	<p>The winner will be notified by phone and email on 22/01/2021. The winner may also be announced on TV by Channel 7 on 23/01/2021 during the Star v Scorchers BBL game.</p>
Prize Claim Date and Time	<p>Prize must be claimed by 5pm (AEDT) on 29/01/2021.</p>

- 1 Information regarding prizes and how to enter forms part of these conditions. By entering, entrants accept these conditions.
- 2 The competition will be conducted during the Competition Period.
- 3 Entries must be received during the Competition Period. Entries are deemed to be received at the time they are received by the Promoter's database and not at the time of submission by the entrant. The Promoter has no control over communications networks and is not liable for any problems associated with them due to traffic congestion, technical malfunction or otherwise. The Promoter is not liable for any consequences of user error including (without limitation) costs incurred in entering the competition. Entrants who enter using multiple accounts may be disqualified.
- 4 Each entrant must remain a follower ("follow" the page) of the @buckethead_coach Instagram Page for the entire Competition Period and up until the time of determination of the winner. Entrants who have "unfollowed" the Instagram Page at the time of determination of the winner will be deemed invalid.
- 5 The Promoter is not liable for late, lost, incomplete, misdirected, incorrectly submitted, delayed or illegible entries, correspondence or claims for prizes due to error, omission, tampering, theft, destruction or otherwise.
- 6 This is a game of skill; chance plays no part in determining the winner. Each valid entry will be individually judged by representatives of the Promoter based on, among other things, its originality and the literary and creative merit of banter.
- 7 Each banter statement must be the entrant's original work. By entering this competition entrants:
 - (a) consent to the Promoter making copies of or publishing the whole or any part of their entry (including the banter statement) and otherwise exploiting the entry and any rights in relation to the entry, to publicise this competition or for any other purposes;
 - (b) consent to a community manager monitoring the entries and asking selected entrants for permission to use their content on the Website, thank them for their entry and direct them to the Website;
 - (c) undertake to the Promoter that their entry is not, and its use by the Promoter will not be, in breach of any third party intellectual property rights;
 - (d) grant the Promoter a world-wide, royalty free, perpetual, irrevocable, transferrable licence (with a right to sublicense) to use their entry submitted as part of this competition for any purpose;

 - (j) warrant that their entry does not include any literary, dramatic or artistic work, or any other item in which copyright subsists, unless the entrant is entitled to do so;
 - (k) warrant that their entry contains no virus or other computer code or material embedded in it which may have a negative impact on the competition, any network or third party computer systems; and
 - (l) warrant that all persons appearing in their video are 18 years of age or older or, if any person is under 18 years of age, that their parent's or guardian's consent has been provided.
- 8 The Promoter may (but is not obliged to) determine at any time, in its absolute discretion, whether or not to publish any entries on the Website, remove any entries once published on the Website, or amend, edit or modify any entries (or any part thereof), or disqualify or invalidate any entry including (without limitation) if the Promoter is of the view that:
- (a) the entry does not comply with paragraph 7; or
 - (b) the entry otherwise breaches these conditions of entry.
- 9 The best valid entry, as determined by the judges, will win the major prize.
- 10 The prize pack is as stated in the Prize Details. The Promoter may decide, in its absolute discretion, to deliver any cash element of the prize via bank transfer.

- 15 If a winning entry is deemed not to comply with these conditions of entry, the entry will be discarded and the prize will be awarded to the entrant who submitted the next best valid entry, as determined by the judges.

- 17 The Promoter's decision is final and no correspondence will be entered into.
- 18 If the prize has not been accepted or claimed in accordance with the Prize Claim Date and Time or if, after making all reasonable attempts, the Promoter cannot contact the winner (or the winner does not contact the Promoter) by the Prize Claim Date and Time, the relevant winner's entry will be deemed invalid and the Promoter will distribute the prize to the entrant who submitted the next best valid entry.
- 19 The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury (including, without limitation, allergies, skin conditions or other reactions), illness or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this competition or accepting or using any prize, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law). Nothing in these conditions restricts, excludes or modifies or purports to restrict, exclude or modify any statutory consumer rights under any applicable law including the *Competition and Consumer Act 2010 (Cth)*.
- 20 Without limiting the previous paragraph, the Promoter and its associated agencies and companies will not be liable for any damage, loss or delay in transit to the prize. The prize will be delivered in Australia only.
- 21 This competition is in no way sponsored, endorsed or administered by, or associated with, Instagram or any other social media platforms. Entrants are providing their information to the Promoter and not to Instagram. Each entrant completely releases Instagram from any and all liability.
- 22 If for any reason any aspect of this competition is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the competition, or invalidate any affected entries.
- 23 The Promoter reserves the right, in its sole discretion to cancel or suspend the competition: if:
- (a) virus, bugs, unauthorized human intervention, or other causes beyond the control of the Promoter, in its sole opinion, corrupt the administration, security, fairness, integrity, or proper operation of the game; or
 - (b) the 2020-2021 BBL Season is suspended, cancelled or delayed due to the COVID-19 pandemic.
- 24 The Promoter reserves the right in its sole discretion to disqualify any entrant who engages in offensive, illegal or objectionable conduct, or who tampers with the entry process.
- 25 The Promoter reserves the right in its sole discretion to amend these terms and conditions, or the operation of the game, at any time as a result of any unforeseen events or circumstances, or any causes beyond the control of the Promoter.
- 26 The Promoter is not liable for any tax implications arising from prize winnings. Independent financial advice should be sought. Where this competition involves, for GST purposes, supplies being made for non-monetary consideration, entrants will follow the Australian Taxation Office's stated view that where the parties are at arm's length, goods and services exchanged are of equal GST inclusive market values.
